This policy has been written having regard to the DfE guidance: Behaviour and discipline in schools advice for Headteachers and school staff, January 2022.

This policy is a whole school policy and applies to all students. This policy aims to

- promote and model good behaviour, self-discipline and respect;
- prevent bullying;
- ensure that students complete assigned work;
- regulate the conduct of students.

### "Good behaviour is a necessary condition for effective teaching to take place." (DES 1987)

Buckswood School accepts this principle and seeks to create an environment in the school which encourages and reinforces good behaviour. Furthermore, it is acknowledged that society expects good behaviour as an important outcome of the educational process.

#### Introduction

At Buckswood School we believe that students have the right to learn in a supportive, caring and safe environment and that high standards of behaviour allow this to occur. It is the responsibility of all people within the school to maintain a calm, caring and purposeful atmosphere, and to promote tolerance and harmony between the different cultural traditions.

Buckswood School has a published Pupil Code of Conduct that we expect all pupils to adhere to. This policy provides details around how breaches of the Code of Conduct are addressed as well as how the School rewards pupils for following the Code of Conduct.

The School believes that the plentiful and appropriate use of rewards will encourage students in their efforts and achievement and will lead to a minimal use of sanctions. Our aim is to encourage respect for others and for property and not to have to punish wrongdoers.

The School has regard for the Equality Act 2010 and makes all reasonable adjustments including issues related to pupils with additional educational needs/disabilities.

The School is aware of its duty to promote good behaviour among pupils and to support them at all times, and will liaise with parents and other agencies as appropriate (eg ESCC, CAMHS, independent listeners and other counselling).

Students should be aware that their behaviour is a significant factor in the reputation and standing of the School in the community.

Where it is considered necessary to remove the pupil (by mutual agreement or otherwise), the School will do its utmost to support the pupil, and parents during transition (e.g. in the providing of references).

#### Purpose:

The purpose of this Policy is to:

- have clear expectations of good behaviour and conduct;
- encourage best practice on the part of staff in developing and maintaining good behaviour amongst students;
- promote a positive atmosphere in and around the School based on a sense of community and shared values;
- develop opportunities for students to take responsibilities for themselves and others and to become involved in the running of the School;
- maintain a healthy balance between rewards and sanctions;
- tackle instances of bad behaviour in a firm, clear manner;
- ensure that a written record is kept of serious sanctions imposed on students.

#### Staff responsibilities:

The Staff at Buckswood School have an important responsibility to model high standards of behaviour, both in their dealings with the students and with each other, as their example has an important influence on the pupils.

They should aim to:

- emphasise the importance of being valued as an individual within the group;
- promote, through example, honesty and courtesy;
- provide a positive, caring and effective learning environment;
- encourage relationships based on kindness, respect and understanding of the needs of others;
- ensure fair treatment for all regardless of age, gender, race, ability and disability;
- show appreciation of the efforts and contribution of all;
- avoid sanctions that could jeopardise the health, safety or dignity of pupils.

Teachers at Buckswood School have the following powers:

- Statutory authority to discipline students whose behaviour is unacceptable, who break the school rules or who fail to follow a reasonable instruction (Section 90 and 91 of the Education and Inspections Act 2006).
- The power also applies to all paid staff (unless the Co-Principals say otherwise) with responsibility for students, such as teaching assistants.
- To discipline students at any time the student is in school or elsewhere under the charge of a teacher, including on school visits.
- To discipline students in certain circumstances when a student's misbehaviour occurs outside of school.
- To impose detention outside school hours.
- To confiscate students' property.

Teachers at Buckswood School can discipline students whose conduct falls below the standard which could reasonably be expected of them. This means that if a student misbehaves, breaks a school rule or fails to follow a reasonable instruction the teacher can impose a sanction on that student.

To be lawful, the sanction (including detentions) must satisfy the following three conditions:

- 1. The decision to sanction a student must be made by a paid member of school staff or a member of staff authorised by the Principal;
- 2. The decision to sanction the student and the sanction itself must be made on the school premises or while the student is under the charge of the member of staff; and
- 3. It must not breach any other legislation (for example in respect of disability, special educational needs, race and other equalities and human rights) and it must be reasonable in all the circumstances.

Any sanction given must be proportionate and in considering what is reasonable. Section 91 of the Education and Inspections Act 2006 says the penalty must be reasonable in all the circumstances and that account must be taken of the student's age, any special educational needs or disability they may have, and any religious requirements affecting them.

The Principal may limit the power to apply particular sanction to certain staff and/or extend the power to discipline to adult volunteers, for example to parents who have volunteered to help on a school trip.

### <u>Corporal punishment is illegal in all circumstances and is not practised at Buckswood School. Buckswood</u> <u>School rejects all Corporal Punishment.</u>

Buckswood School will consider whether the behaviour under review gives cause to suspect that a child is suffering, or is likely to suffer, significant harm. Where this may be the case, school staff should follow

the schools' safeguarding policy. They should also consider whether continuing disruptive behaviour might be the result of unmet educational or other needs. At this point, the school should consider whether a multi- agency assessment is necessary.

### Students' conduct outside the school gates – teachers' powers

Buckswood Teachers have the power to discipline students for misbehaving outside of the school premises "to such an extent as is reasonable"

Subject to the behaviour policy, teachers may discipline students for:

- misbehaviour when the student is:
  - o taking part in any school-organised or school-related activity or
  - o travelling to or from school or
  - o wearing school uniform or
  - o in some other way identifiable as a student at the school.

or misbehaviour at any time, whether or not the conditions above apply, that:

- could have repercussions for the orderly running of the school or
- poses a threat to another student or member of the public or
- could adversely affect the reputation of the school.

In all cases of misbehaviour the teacher can only discipline the student on school premises or elsewhere when the student is under the lawful control of the staff member.

### Managing challenging behaviour

Teachers will be expected to use good classroom management techniques and develop a range of behaviour management strategies

Should a teacher need further guidance and support in doing this, they will speak to their Head of Department, Head of Key Stage or a member of the School Leadership Team.

A range of strategies to deescalate situations can be found in the Use of Reasonable Force and Restraint Policy, and staff will be expected to use these strategies (if appropriate) to diffuse the situation and issue sanctions.

### Confiscation of inappropriate items

### Power to use reasonable force

Members of staff have the power to use reasonable force to prevent students committing an offence, injuring themselves or others, or damaging property, and to maintain good order and discipline in the classroom

For further guidance please see the Use of Reasonable Force and Restraint Policy

#### Malicious accusations against school staff

Buckswood School take all allegations against staff and students very seriously and will investigate all allegations in line with the Child protection and Safeguarding Policy and the school's behaviour policy.

If a student makes a malicious accusation against a member of staff this could have very serious consequences for that member of staff and where a student is found to have made a malicious accusation there will be serious consequence for the student. The School Leadership team will meet to decide on the most appropriate sanction which might include Exclusion (fixed term or permanent)

#### **Pupil obligations:**

Pupils are expected to adhere to the spirit and content of the policy. Disciplinary action may be taken against pupils who are found to have made malicious accusations against staff.

#### **Communication:**

Assemblies and form periods are seen as key channels for promoting and maintaining an ethos of corporate responsibility, consideration of the individual and moral values. These, as well the School's PSHE programme, seek to reinforce positive values amongst students focusing on such topics as relationships, self-esteem, leadership opportunities and working with others.

Where the behaviour of a student is giving cause for concern it is important that all those working with the student in school are aware of those concerns, and of the steps which are being taken in response.

The key professional in this process of communication is the Form Tutor or Residential Tutor who has the major role in the general well-being of pupils in their care. Therefore, they must be kept fully informed on all issues relating to their pupils. These will include commendations, failures, successes, illness, absence, sanctions, bullying and so forth.

Early warning of concerns should be communicated by a Classroom teacher to the Head of Key Stage or the Head of Boarding so that strategies can be discussed with the student's form tutor and agreed before more formal steps are required. If the concern is more serious the Head of Key Stage teacher will inform the Academic Principal and/or Designated Safeguarding Lead.

A positive partnership between School staff and Parents and Guardians is crucial to building trust and developing a common approach to behaviour expectations and strategies for dealing with problems.

### **Rewards:**

• Rewards have a motivational role helping students to see that achievement and good behaviour is valued. The commonest reward is praise, informal and formal, public and private, to individuals and groups. It is earned by the maintenance of good standards as well as particularly noteworthy achievements;

The student reward system involving 'Positive Points' operates across the School. Teachers can reward a pupil Positive Points for good work or conduct. Positive Points are awarded through the SIMS system. Each week the totals for each House are read out in assembly as are the pupils with the most points. At the end of the school year the House Positive Points Cup will be awarded to the House with the greatest number of Positive Points, awarded proportionally. In addition, pupils with the most Positive Points will also be recognised and awarded a certificate (commendation);

Assemblies are held on a regular basis to reward students for effort and achievement in academia
as well as co-curricular activities;

- Sports and Speech Day is held in June each year to reward academic and cultural achievements, and service to the community.
- The school operates a system of badges. All scholars begin the academic year with no badge. Once they earn 150 reward points they earn a red badge, which is pinned to the lapel. As they take part in school life, they earn points for positive events – for example attending access time, playing for a school team, performing in assembly, earning a commendation – and upon earning 250 points they earn a silver pin, moving up to gold after receiving 350 points.

### Sanctions:

Colleagues should have equal expectations of behaviour and performance from pupils regardless of year group or any other category and be prepared to use sanctions accordingly. To this end:

- Staff should communicate clearly to pupils on how offences will be dealt with (depending on circumstances such as severity and re-offending) with verbal warnings, weekday detentions and Sunday Detentions, community service or weekend gatings in further escalation, so that pupils have a clear understanding that teachers will follow through accordingly.
- It is especially important that, when reporting on poor pupil progress or behaviour, staff are able to demonstrate consistent use of interventions to hold them to account and incentivise improvements. Pupils should, as far as possible, have the sense that they are being treated fairly in comparison with their peers and in accordance with policy. Therefore, Sixth Form pupils should be held to account for issues such as dress / appearance, punctuality and prep just as would lower year groups.

All sanctions and the reasons for them must be recorded. **Under <u>no</u> circumstances are corporal punishment or other physical sanctions to be used.** At Buckswood School, negative behaviours are grouped into 3 levels, with level 3 considered the worst and therefore subject to the strongest sanctions. An explanation of sanctions is given in the appendix to the Behaviour policy.

#### **Negative points**

Negative points are given to a pupil who fails to meet our academic expectations or for a misdemeanour. Examples of this might include:

- Failure to hand work/prep in on time
- Producing work of an unacceptable standard
- Lateness to class or any other commitment (e.g. games, activities)
- Being regularly ill-equipped for a lesson (e.g. no text book, nothing to write with)
- Immature behaviour


As far as possible teachers should avoid issuing large numbers of negative points at any one time. A full description of negative behaviours and the points assigned are below:

### 1. Lessons

### (a) Students will:

(i) attend all lessons at the times and locations as specified in their timetable with in the school calendar; and

# 12. Smoking

Students found in possession of smoking paraphernalia or in the presence of students smoking will be subject to the same smoking sanctions as if found smoking themselves. Note that use of e-cigarette devices (vaping) and possession of vaping paraphernalia/liquids receives the same sanctions as drugs at Buckswood.

# 13. Alcohol

(a) Students must not break the UK legislation in relation to the purchase and consumption of alcohol. For the sake of clarity further guidance is as follows:

- i) Students must not be under the influence of alcohol or be or associated with those that are under the influence of alcohol when in the school's duty of care.
- ii) Students over the age of 18 must not purchase or supply alcohol for other students
- iii) Students must not be in possession of alcohol or alcohol containers (empty or full) whilst under the care of the school, irrespective of their age unless relevant permissions have been completed as per the Alcohol Policy.
- iv) Pupils may not, under any circumstances, drink alcohol before driving to or from school.
   Irrespective of whether they are over the legal alcohol limit or not, pupils known to have driven after drinking will have their right to drive to school withdrawn indefinitely.
- v) A pupil committing a first offence will normally be placed on Level 1 with the following exceptions:

a) A pupil who has consumed spirits, brought alcohol of any description onto the school grounds or supplied alcohol to others will automatically be placed on Level 2.

b) A pupil who has brought spirits onto the school grounds, supplied spirits to others, been incapacitated by alcohol or required medical attention as a direct or indirect result of drinking alcohol will automatically be placed on Level 3.

Note 1 - We will make every effort to ascertain where the alcohol was obtained. The details of shops supplying alcohol to under-aged pupils will be passed to the police.

Note 2 - A pupil who returns to school clearly under the influence of alcohol, irrespective of whether a day or boarding pupil or having been in the company or care of his/her parents, will incur the appropriate penalty according to the scale above.

### Appendix 2 - Sanctions

### **Sanctions**

There are 4 detentions that can be set by members of staff for breaches of the rules by students:

### (A) Weekday detention (during lunch break Monday, Tuesday, Thursday)

- A weekday detention is given to a Student if they fail to meet the expectations of their teacher (this includes Clubs, Societies and Weekend lessons). This can include incomplete work, or work of a poor standard. Weekday takes place in the library on the following days: Monday, Tuesday, Thursday.
- If the detention is not completed to a satisfactory standard, or if they miss the sanction, the Student will then be placed in the next detention. If this is then missed, it will be a Sunday detention. If this is missed, a fixed term exclusion may result.

### (b) Sunday Detention

- Sunday Detention will take place on a Sunday Morning. Day students are expected to attend as well as boarders and parents/guardians must make travel arrangements accordingly.
- Where possible, students will be given 24 hours' notice (via SIMS which will automatically notify parents when a negative event is entered)
- Students must wear full school uniform and must work in silence for the entire time.
- There are <u>no portable music players or mobile phones</u> allowed. Laptop use must be supported with a note from the subject teacher.
- All detentions take priority over all other extra-curricular activities, including sport and extra lessons, so students should bear this in mind with their general behaviour.

- If the Detention is not completed to a satisfactory standard, the students will then be placed into a subsequent Sunday Detention/Gating
- This is the most serious in-school sanction. Failure to complete a Sunday detention to the satisfaction of the supervising member of staff may result in a fixed term exclusion.

### (c) Saturday afternoon Detention (Community Service)

- Saturday afternoon detentions take place on Saturday afternoons from 1400 until 1800. They take place around the school campus and are taken by a senior member of staff usually the director of boarding.
- Students are required to be in sports uniform and the supervising member of staff will set tasks for them to complete.
- Saturday afternoon detentions are for both day and boarding students families of day students are expected to deliver and collect their child from the school.

### (d) Weeknight Detention (Boarding Detention)

- Weeknight detentions take place Monday to Thursday in the library from 1700 to 1800
- Students placed in weeknight detention are to attend in School uniform
- Failure to attend without valid reason will result in loss of weekend town leave and a Sunday detention.

What follows below is a list of other sanctions that may be employed should a student not perform or behave as expected.

### (i) Green card

Following assessments, results are analysed and if a student is deemed to have been falling below an appropriate level of effort (Attitude to learning), they may be placed on green card.

- The green card is taken to each lesson and is signed off by the subject teacher indicating the level of 'attitude to learning'.
- Each morning the form tutor must sign off the green card for the previous day. Any concerns are raised with the Head of Key Stage and an weekday detention may result.
- Students will be on green card for at least 1 week and if they demonstrate sufficient improvement will be taken off green card. If they are not progressing they will remain on green card until such point at which improvement is shown.
- Students who are found to be missing lessons without reason may be placed on a similar report in this case it will be called and the same consequences apply.
- In some cases students may be given a green card for poor behaviour or poor attitude to learning as this has been found to help students focus.
- Each Friday following assembly Head of Key Stage will sign off the green card and make a comment.
- Green cards are retained on the student's file for reference.
- Boarding students can be issued with a 'boarding green card' if they are not meeting expectations in the boarding house. This will be signed each day by the resident tutor and reviewed at the end of the week by the Head of Boarding.

### (ii) Smokers reform

The smokers reform sanction takes place on Saturday afternoons from 14:00 until 18:00. Students on smokers must attend in sports kit. They report to Saturday afternoon detention in reception for further instruction and should bring school work in case there are no tasks to complete around the campus. Students on smoker's reform are also gated for that weekend (Saturday and Sunday).

#### (iii) Community Service

Community Service is for Students that have taken away from the community – be it in terms of time or material. Students will be required to perform some tasks to help the community

#### (iv) Gating

- If a boarding Student breaks certain rules as outlined in the school sanctions, they will be gated.
- This means that they are restricted to school grounds and must account for their whereabouts to a member of staff by having the gating sheet signed off every hour.
- Housemasters will refer a Student for gating to the Director of Boarding.
- The length of gating is determined by the Director of Boarding.
- Minimum length of gating is 2 hours, with maximum being all weekend.
- Gated Students may be required to remain in school uniform.
- Failure to complete a gating correctly will result in it being extended and possible further sanction.

#### (v) Exclusions

### Appendix 3 - School Uniform & Personal Appearance

Whilst the school recognises each student's right to express their individuality, there are certain expectations as regards appearance and uniform required of Buckswood students. This constitutes part of the contract between the school and student when a student signs up to be a member of our community. Students must consider this when deciding on whether or not Buckswood is an appropriate school for them. A uniform removes symbols of status/difference and breaks down barriers between students, forging closer relationships and a greater sense of community and as such is key to the Buckswood family.

Members of the school are expected to ensure that their appearance and dress are, on all occasions, presentable and appropriate and such as to bring credit to them, their families and the school. The correct dress must be worn at all times. The school uniform consists of clothing worn during the academic day and official games kit. It is essential that all students are familiar with the dress code. All students are required to wear school uniform at any event in which Buckswood is taking part. This would include field trips and sports matches played at other schools. Students must depart school at the end of term in school uniform – not in casual clothes. This applies to both day and boarding students. If you are supporting Buckswood please wear and be proud of the Buckswood uniform. The correct uniform is to be worn to all school activities.

#### **School Uniform**

a) Black trousers (not jeans, not 'skinny' fit or flared) to be worn with white shirt, school jumper/waistcoat and school tie (boys/girls) (Students may wear any official school tie as part of their uniform). On Fridays, bow ties to be worn by 6<sup>th</sup> form pupils. School kilt to be worn on or below the knee with either white shirt and tie or white open necked blouse (boys/girls). Lower Sixth girls may wear black skirts that must sit at or below the knee or black trousers (not jeans, not 'skinny' fit or flared). Skirts must be purchased from the school uniform shop. <u>All trousers must be appropriate for school – not 'skin tight' or 'flared' for example and of an appropriate length.</u> For appropriate examples see below:



b) School Blue V Neck jumper or waistcoat is worn in addition to the blazer <u>and not instead of the blazer</u>. Lower Sixth students may wear their own waistcoats and coloured shirts (not black – except on Mondays) if they wish.

c) School blue blazer – Form 1 to Lower 6<sup>th</sup>.

d) Blue or black tights (no socks) to be worn with school kilt/Lower 6<sup>th</sup> skirt or grey/black socks to be worn with school trousers.

e) Black shoes must be leather or leather look and must be a traditional shoe that can be polished. <u>Canvas shoes,</u> <u>trainers or trainer style shoes (including for example VANS and Nike Airforce) and boots are not acceptable</u>. <u>Dr</u> <u>Marten style shoes/boots may not be worn either</u>. Shoes must be polished regularly.

f) One pair of stud earrings in the lower earlobe as well as one discreet gold or silver chain necklace and one bracelet. <u>No other jewellery/piercings are permitted</u>.

g) Hair should be discreet in style, worn tidily and in a natural tone. Make up should be discreet – <u>no coloured</u> <u>nail polish is allowed</u>. All pupils should be clean shaven unless there is a medical exemption provided. Pupils are expected to present a smart appearance when at school.

h) School coats can be purchased to be worn <u>over</u> the blazer during colder months. No other coats can be worn with school uniform.

i) In the Summer Term an announcement will be made about blazers being removed when the weather is warm enough.

j) Upper Sixth Students may wear business suits with their school tie (boys) and a shirt appropriate for a business environment. The suit jacket and trousers/skirt must match.

k) Top buttons must be fastened when ties are worn and waistcoats are to remain buttoned at all times with the exception of the bottom button.

I) Uniform should be clean and tidy each day.

m) Students not correctly dressed for school face being sent back to their room to dress properly. If they are a day scholar, they face being sent home at their parent's expense, to dress correctly

n) Students must have their student ID card with them at all times and are required to present it to a member of staff when asked.

#### Games Kit or Academy Kit

It is one of the school rules that all students must be correctly dressed for their sports commitments. Tracksuits, T-shirts and other gear, which were made for specific events or tours or other 'one-off' occasions may not be worn around the school.

Please note the following:

- When you travel to other venues or schools to play or watch, you must wear either the normal everyday uniform or the official games kit.
- If watching any Buckswood match, you must wear school uniform.
- Games kit consists of the Buckswood sports jersey, shorts and sports socks.
- A blue Buckswood tracksuit top and/or trousers may be worn on particularly cold days.
- Games kit may not be worn in class unless the next lesson is games.
- Football or rugby boots are not to be worn inside buildings. Muddy footwear must be removed from feet before going inside.
- Students should change out of games kit in the break immediately following a games lesson. Games kit is not to be worn during prep.

#### **Casual Dress:**

Students are not permitted to wear casual dress during the academic day (unless with express permission), or before lunchtime on Saturdays

Students may not leave the school grounds in casual dress during weekdays, unless with the Principals' permission. School trips are in school uniform (this might be games kit if the trip requires it).

Day students may not be on the school grounds in casual dress during weekdays, or on Saturday mornings. This includes on school transport at the end of the academic day. Day students who attempt to board school transport at the end of the day not in school uniform will not be allowed to board.

These rules apply to ALL students and apply throughout the year, including the period of examinations.

The School encourages any team or group wishing to organise special attire such as T-shirts or touring tracksuits to do so. Approval for the designs must be obtained from the School Director or Principals before any orders are made.

Occasionally, students that have organized a special T-shirt or other attire will be permitted to wear this item of clothing over jeans on a school mufti day.

Casual dress worn by students may not contain offensive language or inappropriate images. Advertisements for drugs, tobacco or alcohol on casual clothing are prohibited and will be confiscated and disposed of.

Exceptions: Day students may travel home after sport in their games kit. Boarders may leave and return for the weekend in casual clothes

### Tattoos

Students are expected to cover any tattoos that might be visible outside of their school uniform.

# Appendix 4 - Student Code of Good Conduct

### Introduction

All pupils must know and, when under School jurisdiction, observe this Code of Conduct. This is a positive framework within which we live and work together for the benefit of the community as a whole. It is a contract between you, the pupil and the school.

We believe that it is important that our pupils and staff understand the importance of being good citizens, and we want you to behave in a way that is ethically and morally responsible.

We believe that the best form of discipline is self-discipline. With this in mind, you are expected to show courtesy and respect towards all members of the School and wider community, to behave responsibly, to work to the best of your abilities, and to conduct yourself at all times in a way that enhances your own reputation, and that of the School.

Any disregard of common sense, good manners, respect for others and their property, and any improper behaviour is considered to be a breach of this Code of Conduct.

This code of conduct is built on the Buckswood 12 Pillars, which are central to the School's ethos.

### 1. Academics

The main purpose of being at Buckswood School is to learn to work to the best of our abilities and, with this in mind, all lessons **must** be attended. A positive approach to learning is commended. Disruption to the learning of others is not tolerated. Your teacher is in charge in lessons – remember this and follow the classroom code of conduct that is up on each classroom's wall. (See Appendix 2 at the end of this Code of Conduct)

### 2. Sport

Pupils have a responsibility to make the most of our many facilities and activities; these enhance your School life and experience. Physical activities are arranged by the Academies and Games department and are published by them. Exercise is a key component to good mental health and as such all pupils take games lessons as part of their school experience. Additionally, every pupil is given the opportunity to represent the School in competitive sports fixtures.

Pupils should participate in a minimum of one non-sporting club or activity, at least once a week. Pupils are expected to support cultural events by attending, if not directly involved. Education is not just about academics – it is about learning new skills in a variety of areas. Participation in extra-curricular clubs and activities is key to this.

#### Please refer to Appendix 3 about uniform for more information on sports kit.

### 3. Appropriateness

The way in which we present ourselves is of fundamental importance. Pupils must dress in line with the School's Uniform Regulations (See Appendix 1 below). Your appearance is your 'window to the world' – take pride in your appearance! Polish shoes regularly, make sure your uniform is clean and ironed!

All pupils must arrive dressed appropriately for the start of the School day. Boarders should arrive for Breakfast dressed appropriately for the start of the School day. Sports kit must be brought in a bag into school and can be kept in the changing rooms – pupils do not go back to boarding houses to change during the day.

School uniform is worn on all formal occasions, and as directed. Official games kit is worn for all School matches and practices. Players should appear neat and tidy.

**Relationships** - It is important that all relationships are based on mutual trust and respect. There must be a recognition that each and every one of us is a person of equal value. There is no place for harassment or misogyny at Buckswood. The School recognises that not all relationships are consensual and as such will take a firm line on such situations – the Wellbeing Hub is here to support students should they be in such situations. Private affection should be kept private.

**Assembly** - Assembly brings the whole School community together; <u>all pupils are expected to attend</u>. Assembly provides an opportunity for reflection and for quiet contemplation. Irrespective of religious belief (and Assembly is not religious in nature), opportunities for reflection are highly valuable in an increasingly busy society. Silence should be observed from entering the Great Hall. Remember that we have a tradition of listening thoughtfully to the readings and address, celebrating success appropriately and participating where relevant.

### 4. Spirituality

Reflection on life's fundamental questions and beliefs are an important part of daily life at Buckswood. It is important that all pupils give each other the respect and space to reflect when it is required. When moving around the campus, it is expected that pupils are respectful to one another, that they respect each other's religious beliefs and cultures and behave accordingly. If you wish to attend religious services locally, this can be arranged by the school. Our beautiful campus provides ample space for reflection and appreciation of the beauty in the world around us.

### 5. Manners

As we go about our daily lives, manners are very important. This starts with understanding that a recognition of each other, no matter how brief, is important, as is a warm welcome towards all visitors. It is a common courtesy that we extend a greeting to everyone who visits the Buckswood site. Our community is known for being warm, friendly and welcoming and through our actions, we will make sure that this continues.

Members of our community are expected to greet those we pass with a verbal greeting (Good Morning, Good Afternoon, Good Evening), a nod of the head, a smile, or a wave. This means that our heads are up, and we are conscious of those around us and aware of our surroundings. We are present. Additionally, this means that we are holding doors open for those coming in the opposite direction, or standing back to let someone else through a doorway before going through ourselves. It means standing up when a visitor enters the room. It is fundamentally about respecting those around us, no matter who they are.

Manners also extend to the dining room - where during meals, students are expected behave in certain ways -

- To eat with correct table manners, sitting up straight, keeping elbows off the table and not speaking with a mouthful of food. Conversations should be restricted to immediate neighbours.
- Do not stretch across the table ask your neighbour to pass the item to you.
- Use the cutlery (knife and fork/chopsticks) properly
- Do not spread ketchup etc. all over your meal. Place it on the side of your plate otherwise it could be thought of as an insult to the cook.
- Do not lean on the table or put your elbows on the table

### 6. Home

As well as being a School, Buckswood is also a home. And as such, it has rules and boundaries that everyone needs to follow and respect! Boundaries exist to support the safety and wellbeing of everyone at Buckswood School. Should you go out of bounds, you are then not only potentially endangering yourself, you are also creating additional work for those who have to look for you – in short, it is not supportive of the wellbeing of our community.

**Boundaries** – All pupils must remain within the School grounds during the School day, unless specific permission has been granted. (See Appendix 6 for a clear list of Out of Bounds areas.) Boarders may only leave their House after evening prep with resident tutor's permission. Houses and House facilities (other than your own) are out-of-bounds to non-residents at all times. <u>Boarding Houses are out of bounds to all pupils from 0845 until 1700</u> <u>Monday to Friday</u>. Permission for absence from school must always be requested from and granted by the Head of Boarding (for boarders in the case of weekend leave) or the Academic Principal (during the academic day). Any departure from school must be registered by signing out – it is important that the School knows who is here. It is a common courtesy, expected of all pupils, to excuse yourself with the appropriate member of staff when a lesson or activity has to be missed for whatever reason. You are expected to attend all meals, lessons, activities and sport/exercise unless excused by the Buckswood Health Service. You must attend Roll Calls and Sign In and Out according to House Rules.

**Town Leave** may be given between 1.00pm and 6.00pm on Saturday afternoons for all pupils. There is additional 6<sup>th</sup> form town leave on Sunday mornings from 9.00 am until 1.00 pm. School commitments always take priority. **Weekend Leave** requires documentation to be completed at by the prior Wednesday at the latest.

Day pupils should only be in School after 5.30pm on weekdays with specific permission from your Form tutor.

**Property** – Respect for one's own and other people's property is a fundamental responsibility of all members of Buckswood School. We live and work in a beautiful setting. We ask everyone to please appreciate the hard work done by the support staff to provide us with a safe and clean working environment. To this end, make sure you use the litter bins available and keep the School clean, tidy and free from vandalism, graffiti and chewing gum. Please report any accidental damage to a member of staff.

### 7. Charity

Each pupil is expected to contribute in some form to good causes. Charity does not have to be by giving money – it could be through giving time to others. It doesn't have to be outside of school, but can involve being a positive member of the community and giving up your time to help others – be it students or staff members. It is important to remember that everyone in the world has value and it is everyone's responsibility to help each other. There are many charitable opportunities at Buckswood for students to engage in throughout the year. For some students, there is the opportunity to go Eswatini and take part in the annual charity trip there.

### 8. Adventure

Life is an adventure. We expect all Buckswood pupils to take advantage of the opportunities that a Buckswood Education provides them with. To say 'Yes' to new opportunities and to move outside of their comfort zones. Adventures can be as small as learning an instrument, a new language, trying a new sport, talking to someone from another part of the world. Or they can be as big as going on a school trip to a different country, inviting a

boarder home for the weekend, taking flying lessons or signing up to the Duke of Edinburgh Award scheme. Adventures come in lots of shapes and sizes and it is expected that all pupils seek out the opportunity for adventure.

#### 9. Talent

At Buckswood our School Prayer states 'Let us remember that at Buckswood every child has a talent. It is our job to firstly find that talent and to encourage each and every child to be the best at what they do. Here at Buckswood it is our responsibility to cast the net of opportunity so wide that any talent gets a chance to develop and to ensure that many of these talents should be just as highly ranked as academic scholarship.'

With this in mind, we expect every pupil to try new things and take advantage of new opportunities so that they can find their talent. With any talent, there is a responsibility on the pupil as well as the teachers to develop their talents and to help others to also develop their particular talents. This includes participating in assemblies, getting involved in the school Debating Society, horse riding, joining the rugby academy or other similar examples. You are not at school to sit still – life is not a dress rehearsal!

#### 10. Internationalism

As a school made up of over 35 different nationalities, Buckswood is truly an international school. With this in mind, each pupil is expected not only to have pride in their national identity, but to also respect and celebrate the many other nations represented here. You are expected to be a positive ambassador for your country and to have an open and enquiring mind about the cultures, languages and traditions of others. Whilst there may be differences and at times there may be difficulties between nations, here at Buckswood it is everyone's responsibility to show the world how an international community can be a positive force for good! As we are located in England, it is expected that all pupils speak in English during the academic day as this is a common language and is therefore inclusive to all. For British pupils, attending Buckswood is a unique opportunity to make friends from all over the world.

### 11. Wellbeing

Pupil wellbeing is central to everything that happens at Buckswood. We expect all pupils to respect this and to think about how their actions could be impacting on the wellbeing of others as well as themselves. In this respect, pupils should be considerate around things like playing music at loud volumes, about shouting around school, about teasing others, about keeping the school neat and tidy, about showing respect to your teachers and not creating disruptions in lessons – in short, Buckswood expects pupils to think before they act and to consider the needs of others as part of any decision making process. If you have concerns about your own wellbeing or that of somebody else, these need to be reported to staff members so that the school can help resolve matters. We are a listening school and the staff are here to support you.

We expect pupils to make healthy choices as regards what they eat and drink – to carry a water container with them to stay hydrated and to engage in PHSE lessons which will help with being healthier. Regular exercise is important in looking after mental and physical wellbeing so many opportunities are available for this. Buckswood has set lights out time for boarding pupils in the evenings which must be observed as these contribute to overall wellbeing as well.

**Mobile phones** - these are very useful tools – however, responsible use is encouraged as when not used correctly they can negatively impact on wellbeing. Misuse is subject to sanctions in accordance with the School's Behaviour Policy. The use of mobile phones is restricted during the academic day. We do **NOT** expect to see mobile phones around the School (in the corridors, the Lunch queues, the Dining Hall, etc.) Phones may not be used in the Dining Hall or Great Hall. In the classroom, mobile phones can only be used with the express permission of the teacher. Photographs and/or videos of other people must only be taken with their express permission; there are legal implications to taking/using/sending images (e.g. Child Protection, Copyright Law).

#### 12. Success

At Buckswood we want every pupil to be the best version of themselves. Success comes in many different forms, but we want to celebrate success wherever it happens! Each week assembly is a focal point for this celebration and we expect all pupils to positively contribute to celebrating success. We expect all pupils to actively seek out opportunities for success – to see challenge as opportunity and to push themselves. A Buckswood pupil is successful because they want to be.

Success comes by bringing others with you – through teamwork and collaboration. We do not expect arrogance when you do well! Success comes through hard work and making positive choices. We expect all Buckswood pupils to do this. To engage positively with your teachers and peers and make sure that when you leave Buckswood you have made the most of every opportunity and are prepared for a successful life.

### Appendix 5 - Boarding House Rules

The Boarding House Rules supplement the normal school rules. The school rules apply to all boarders when they are at school and in their Houses. These should be strictly adhered to by boarders. They are designed to create a positive, safe climate, and they set out the expectations of those within that climate. They teach boarders that there are limits to the behaviours that they may engage in, and that these limits are to train them to behave appropriately within a civil society.

### 12. Alcohol

Students must not break the UK legislation in relation to the purchase and consumption of alcohol. For the sake of clarity further guidance is as follows:

- a) Students must not be under the influence of alcohol or be or associated with those that are under the influence of alcohol when in the school's duty of care.
- b) Students over the age of 18 must not purchase or supply alcohol for other students
- c) Students must not be in possession of alcohol or alcohol containers (empty or full) whilst under the care of the school, irrespective of their age unless relevant permissions have been completed as per the Alcohol Policy.
- d) Pupils may not, under any circumstances, drink alcohol before driving to or from school. Irrespective of whether they are over the legal alcohol limit or not, pupils known to have driven after drinking will have their right to drive to school withdrawn indefinitely.
- e) A pupil committing a first offence will normally be placed on Level 1 with the following exceptions:
- A pupil who has consumed spirits, brought alcohol of any description onto the school grounds or supplied alcohol to others will automatically be placed on Level 2.
- A pupil who has brought spirits onto the school grounds, supplied spirits to others, been incapacitated by alcohol or required medical attention as a direct or indirect result of drinking alcohol will automatically be placed on Level 3.

Note 1 - We will make every effort to ascertain where the alcohol was obtained. The details of shops supplying alcohol to under-aged pupils will be passed to the police.

Note 2 - A pupil who returns to school clearly under the influence of alcohol, irrespective of whether a day or boarding pupil or having been in the company or care of his/her parents, will incur the appropriate penalty according to the scale above.

## Appendix 6 - School Boundary Areas


### **Out of Bounds**

The following are out of bounds to any student not accompanied by a member of staff:

- All classrooms, labs and lecture rooms (out of class time).
- Ladies sitting room during lesson times.
- Boarding residences during the academic day.
- The maintenance and workshop areas, the stables.
- The Buckswood Health Service, except during official visiting times.
- The sports fields, back fields and any neighbouring farmer's fields, including those across the street from the school, the woods, all roof areas.
- The Astro-turf, Orchard and Vineyard and areas behind the Astro-turf.
- All staff quarters and the Staff Room.
- The School Dining Room outside of meal times.
- Another Scholar's dormitory room, unless members of that room are present and you are a member of that residence. All changing rooms in residences other than your own. Students are not allowed to enter boarding houses unless they are members of that house. This is especially true in regards to boys being in girls' dormitories and vice versa.
- Off Campus except for those officially signed out, going to town.
- Pubs, off-licenses, so-called 'head' shops which sell drug paraphernalia, betting shops.
- Rooftops, attics and crawl spaces anywhere at school.
- The school library after hours.
- TJs after the school day ends.
- The sports hall and gym unless a member of staff is present.

### **Swimming Pool Rules**

- The pool may only be used when there is an accredited supervisor i.e.: A person qualified to supervise swimming, with a lifesaving qualification and who has authority to control students.
- Behaviour in the pool area must be scrupulously correct. No food or drinks are allowed in the pool area. No games except for water polo. No pushing, chasing, ducking or other horseplay. No stereos or mp3 players are permitted in the pool area.
- Correct swimming attire must be worn.



# Appendix 7 - Explanation of Prep

- Prep must be entered into the scholar's prep diary at the time it is set. The prep diary must be brought to prep for inspection. If a scholar is absent from a lesson, they must access the prep task by asking a classmate or the teacher.
- It is the responsibility of the scholar to understand the Prep assignment at the time it is set. If the student does not understand he/she must ask the teacher concerned.
- Once Prep has started, students may not leave that room.
- <u>Prep must be done in silence.</u>
- Reading books should be brought to prep, in case work is finished early.
- Boarders during prep, students may use technology in an appropriate and non-disruptive manner. Any scholar found using technology inappropriately during prep will have it confiscated and may face further sanction.
- If students are late to prep, they will be made to remain behind to make up the time.
- Lesson 7 (which is when 1<sup>st</sup> prep takes place) runs from 1600 1700 Monday to Thursday and 2<sup>nd</sup> Prep for boarders runs from 19:30 until 21:00 – this is compulsory. On Wednesday there is double prep for boarders in the evening.

## Appendix 8 - Guidance around gambling

These rules exist to:

- 1. Promote good, socially acceptable behaviour that is in line with the law.
- 2. Support staff in developing an awareness of the adverse effects of gambling.
- 3. Follow correct procedures should a staff member have any concerns around the issue of gambling.

These rules are necessary so that students and staff are kept safe at the School, for the reputation of the School and for the protection of Buckswood's property and environment. They help to engender a healthy living and educational environment where young people can learn together and thrive. These rules apply to all students whilst they are at School, representing the School, on School trips & visits, travelling to and from school, wearing School uniform and when students are associated with the School at any time.

### Current research in Gambling amongst young people.

Research in England and Wales conducted by the Gambling Commission shows that children agree that gambling is dangerous and can have very negative consequences.

The most popular forms of gambling are fruit machines, placing a bet with friends, playing cards for money with friends, The National Lottery and gambling online. Gambling is twice as prevalent among boys (21%) as among girls (11%)

Increasingly, on line gambling is becoming popular with some young people using their own money, while others are using a parent's account, with or without permission.

Young people are seeing gambling as a means to make money, to have fun and find excitement.

Gambling advertising is used increasingly on social media websites, which many young people use.

## A definition of problem gambling.

Problem gambling occurs when one loses control over the amount of time and money one spends on gambling, despite adverse consequences.

### Consequences of gambling.

Some of the problems manifested by habitual gambling in schools are:

- 1. Poor grades, possibly going from high to low in achievement and results.
- 2. Stealing and lying.
- 3. Borrowing money and not repaying it. 4. Extortion of money from younger students.
- 5. Having money or debt that cannot be explained satisfactorily.

### Some possible signs of gambling

- 1. Apathy at school, reluctant to take part in events and fully engage in the lesson.
- 2. Poor social relationships.
- 3. Tiredness.
- 4. Clear drop in results and levels.
- 5. Increased anger or aggression.
- 6. Repeated attempts to access gambling sites blocked by the school 'Smooth wall' filtering system.

### **Procedures if concerned**

Any form of gambling behaviour cannot be tolerated as it can do harm to the climate and safety of the school as well as to the individual.

Any students that cause concern around gambling issues must be reported to the School Leadership Team and a welfare form, a green slip, handed to the Designated Safeguarding Lead (DSL)

The student(s) in question need to be continually monitored and checked for any further signs of gambling or illegal activities and will be overseen by the DSL.

Staff on supervision duties and all boarding staff should be very vigilant of any gambling taking place and address the issue immediately with the full force of the school's behaviour policy, inform the School Leadership and the DSL.

## Appendix 9 - Code of Class Conduct

- Line up outside the classroom and wait for your teacher
- Stand behind your desk until asked to sit
- You must sit where your teacher asks you to sit
- Come prepared with relevant materials and equipment
- Raise your hand to contribute a comment or answer
- Be helpful & polite to those around you

- Follow your teacher's instructions at all times it is the teacher, and only the teacher, who is in charge in your classroom
- Ask your teacher if you don't understand something
- Do not walk around the classroom
- Do not eat or drink in the classroom OR bring food/drinks into the class
- Mobile 'phones must not be used for any purpose in the classroom. Teachers will confiscate electronic gadgets, (e.g. 'phones, headphones) if they see them in evidence in the classroom being used without permission
- English is the public language of the school and except in foreign language lessons, must be used at all times in the classroom
- Have your prep diary signed by your teacher before leaving the room in an orderly manner
- If you feel that you have been wrongly sanctioned speak to your teacher privately about it in a diplomatic fashion
- Have FUN learning!

## Appendix 10 - School travel and Transport

- Only those day students with licenses and with parental permission may drive motorcars or other motorised vehicles. Vehicles may only be driven to and from the school with the permission of the Principal.
- No student may ride in, or on, a vehicle driven by another member of the school whilst on the school property, unless he or she has obtained permission from the Principal and both sets of parents.
- No scholar may keep a car at the school unless he or she has permission from the Principal.
- Hitch-hiking is forbidden for all members of the school.
- When travelling on school transport, students are expected to follow all school rules and behave in an appropriate manner.
- Seatbelts are to be worn on all school transport.
- Failure to adhere to the policy on behaviour on school transport will result in this privilege being revoked.
- Students may not book taxis for collection from school. All taxi bookings must go through the school.

## Appendix 11 – Time out procedures

When we issue a student with a 'time out' card, the school have already identified that this student would benefit from leaving class to go to either the HUB or SENCo. Here, the student will have the opportunity to regulate their emotions and behaviour in a calm environment before returning to class to learn.

The way we use the 'time out' card is clearly explained to the student. Initially, the student is introduced to the 'Anger Thermometer', so that a dialogue can take place to discuss the triggers that offset the need to leave the classroom. This is done with the SENCo or Head of Key Stage. This dialogue helps the teaching staff to identify the needs of the student and how to best support them with their learning. The 'Anger thermometer' is also used to determine the students level of frustration/anger and both the student and the member of staff will discuss at what point should they leave the class.

Students are given a 'time out' card and are advised to keep these in their blazer pockets for easy access. It is explained to the student that they can show the 'time out' card to leave the class if they are in a heightened state (already identified on the 'Anger Thermometer'). It is explained to the student that when they use the 'time out' card, they must go to either the SENCo or to the HUB.

A clear procedure must be followed by both student and members of staff: -

- When the student identifies that he/she is in a heightened state and needs to leave class, he/she will show the 'time out' card to the teacher. The member of staff will allow the student to leave the class without an explanation.
- The student will be allowed to go to either the SENCo or the HUB to self-regulate in a calm environment.
- In the meantime, the class teacher will email both the SENCo and the HUB. In the subject box, the teacher will enter the student's initials/TO/time of leaving class. For example- RR/TO/10.56.
- A time-out strategy is used only for the minimum period of time necessary for the student to regain enough composure to be able to return safely to their class. HUB and/or SENCo to discuss behaviour and welfare with student.
- Student to be returned to class with member of staff from HUB/SENCo.
- HUB or SENCo to record/log T/O ('Time out' log in time out folder).
- HUB or SENCo to email appropriate staff accordingly.
